



Terms and Conditions - Raffle Rules

Each ticket will cost \$25.00 (Twenty Five Dollars) per ticket. Your ticket is a receipt for your purchase and represents one opportunity to win a Brand New 2015 Nissan Sentra. The Tubman Museum will assume all responsibility for tag, title and sales tax. Ticket purchases are tax deductible.

Winning ticket holders need not to be present to win.

Ticket sales shall end approximately around 6:30 pm on May 16, 2015.

By purchasing a car raffle ticket, winners agree to allow The Tubman Museum to release their names and use their likeness to promote the Nissan Sentra raffle, or to announce the winner. No compensation will be given for the use of photos and/or testimonials. Winners will also be listed on the website within 10 days of raffle drawing.

The Raffle is conducted by The Tubman Museum with the physical address of 310 Cherry Street, Macon, GA 31201. The Official Rules of the Raffle are set forth herein. By entering the Raffle, Entrants agree to be fully and unconditionally bound by these Official Rules, waive any rights to claim ambiguity in the Raffle or these Official Rules and further agree to be bound by The Tubman Museum decisions and interpretation of these Official Rules.

A maximum of Two thousand five hundred (2,500) tickets will be issued and available for purchase. No refunds will be made, except as otherwise determined by The Tubman Museum in its sole discretion.

Subject to availability, Entrants may purchase as many Tickets as they wish. Each Ticket is personal and can only be in the name of one (1) individual Entrant. Entrants may not sell, donate or otherwise transfer their Ticket(s) to anyone. Prizes will not be issued to anyone other than the one (1) Entrant whose name is on the Entry Form. Title to the car shall be taken in the name as it appears on the Raffle Ticket stub and is not transferable or assignable.

The Tubman Museum reserves the right to disqualify false entries or entries suspected of being false, and any illegible, defective, incomplete or physically altered Entry Forms and entries that do not include valid or complete payment. The Tubman Museum is not responsible for printing errors in any Raffle-related material, or for lost, late, misdirected or non-delivered mail or corrupt fax messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines. All entries become the property of The Tubman and will not be returned.

Drawings:

Grand Prize Drawing: One (1) random Grand Prize drawing will be conducted by a representative of a CPA firm as described below.

Notifications:

Odds:

Odds of winning depend on the number of Raffle tickets that are sold but not to exceed 2,500.

All personal information collected by The Tubman Museum will be used for administration of the raffle. The Tubman Museum will not share, sell or otherwise distribute personal information collected by The Tubman Museum except as stated above.
